UVRF OFFERS SPRING AND FALL RACING PROGRAMS TO AREA STUDENTS IN GRADES 7 - 12, REGARDLESS OF ABILITY TO PAY. 47 STUDENT ATHLETES PARTICIPATED IN OUR LEBANON SPRING PROGRAM. THIS PROGRAM USUALLY RUNS FROM MID-MARCH TO JUNE WITH A FULL RACING SCHEDULE. HOWEVER IN 2020, THE PROGRAM WAS RESTRICTED TO ERGING VIA ZOOM. THE 6-WEEK FALL CREW RACING PROGRAM WAS CANCELED FOR 2020. ANY UPPER VALLEY HIGH SCHOOL ROWER IS WELCOME TO JOIN, WITH GENEROUS FINANCIAL ASSISTANCE AVAILABLE.

4b (Code:) (Expenses \$ 26,078. including grants of \$) (Revenue \$ 2,657.) IN ADDITION TO THE COMPETETIVE PROGRAMS, UVRF OFFERS A VARIETY OF INSTRUCTIONAL PROGRAMS TO ROWERS OF ALL LEVELS. THIS YEAR THE ORGANIZATION ADDED A "CREW" PROGRAM FOR CANCER PATIENTS AND SURVIVORS WHICH OFFERED INDOOR AND ON THE WATER PROGRAMS. THIS PROGRAM HAD 10 PARTICIPANTS. IN RESPONSE TO COVID, UVRF OFFERED A NEW RENTAL PROGRAM WHERE MEMBERS COULD RENT ONE SINGLE AND ONE SET OF OARS FOR ONE MONTH AT A TIME. FAMILY MEMBERS WERE ABLE TO RENT DOUBLES. THIS ALLOWED MEMBERS WHO DO NOT OWN BOATS TO SAFELY RENT BOATS FOR INDIVIDUAL USE. THERE WERE 40 PARTICIPANTS OUR VARIOUS COACHED SCULLING CLINICS. DURING 2020 ONLY PRIVATE OR SMALL GROUP CLASSES WERE OFFERED. NO SWEEP PROGRAMS WERE OFFERED IN 2020 TO AVOID THE SPREAD OF COVID.
